

2025-2026 Texas Aggie Graduate Grant (TAGG) Application

ELIGIBILITY REQUIREMENTS:

- Be a Texas resident.
- Enroll half-time (5 hours for fall/spring, 3 hours for summer) in a degree-seeking graduate program or a financial aid eligible graduate certificate program. Students enrolled less than full-time (9 hours fall/spring, 6 hours for summer) will have their award prorated.
- Complete a FAFSA or TASFA for the 2025-2026 Academic Year and the attached application.
- Law, DVM, and Health Science Center TAGG funds are offered through a separate process. Students enrolled in these programs should not complete this application.
- Students enrolled in distance education graduate programs in the School of Law or programs offered at the Texas A&M University Washington D.C. site are ineligible. These programs are not supported with state funds and do not qualify for state financial aid (per Texas Education Code Sec. 52.2002/Sec. 54.545).
- TAGG recipients may not receive full tuition payments from any source (university, federal, state, veterans' benefits, corporate, or other tuition assistance) during the same term TAGG funds are received. (Note: TAMU Staff Tuition Assistance is not considered full tuition payment).
- TAGG recipients may not receive scholarships or fellowships totaling \$10,000 or more for master's/certificate students and \$15,000 or more for doctoral students.
- Student eligibility will be checked at the time of awarding, after the census date of each award term, and periodically throughout the semester. Should a student no longer meet eligibility requirements at any point during the semester, the award may be subject to partial or full cancellation or proration.
- Awarding is based upon need & priority date with a maximum award amount of \$5,000 per academic year.
